#### **Description of the 2026 Tour**

The tour dates are:

28 January 2026 - 11 February 2026

Unless other arrangements have been made in writing, tours will begin on the evening of 28 January 2026 at a hotel at/near the Buenos Aires Airport (EZE) in Argentina and end on the morning of 11 February 2026 at a hotel in Buenos Aires City Center. The tour will visit Volga German villages in Entre Rios and Buenos Aires Provinces, Mendoza, Bariloche, and Buenos Aires City.

#### Hotels/Meals/Transportation/Tours

**Hotels:** Tour includes 15 hotel nights. All hotels are clean and comfortable. All hotel rooms have a private bath. Single room upgrades are available at additional cost. WiFi is available in all hotels.

Meals: Breakfast following each hotel night is included. All other meals are at the individual expense of the tour participants (with a couple of exceptions). All alcohol and drinks ordered separately are not included. Meal stops may afford locations that can provide dietary accommodation (like vegetarian options), but not all locations guarantee availability of dietary accommodation. Volga German Tours assumes no responsibility for preparation of meals.

**Transportation:** Tour will include motorcoach and domestic air travel within Argentina including transfers. There may or may not be assigned seating on motorcoaches and planes. Incidental transportation such as by taxi, shuttle, or other hired service is not included in this tour. International air transportation is not included.

**Tours**: Museum admittance fees as described on the itinerary are included as are tour guides.

# Cost, Payment, & Cancellation

[All sums are indicated in US dollars.]

**Cost:** The total tour cost per person is \$5,700 (double) or \$7,000 (single).

Tour Price Does Not Include: passport & visa fees, phone calls, valet/laundry service, meals (other than breakfast following each hotel night), alcohol of any kind, baggage fees, and travel or medical insurance. Payment: Deposit of \$1,000 per person is due with

tour application. Following application acceptance, payment in-full is due to Dr. Mai on or before 18:00 Eastern Time on 15 November 2025.

If Application is made after the due date, full payment is due with Application. Payment will not be processed until Application has been accepted. All responsibility for receipt of payment is assumed by the applicant. If Application is not accepted, payment will be returned. Payment indicates understanding and acceptance of all terms and conditions as outlined in this General Conditions document.

Reservation Acceptance: There is space for a limited number of participants on this tour. Consideration of Applications will be made in the order in which they are received. Each participant will be notified by Dr. Mai when their Tour Application Form has been received and accepted. Do not make other travel plans until you have been notified by Dr. Mai that the Tour Application Form has been received and accepted. Failure of full payment to be received by Dr. Mai before 18:00 Eastern Time on 15 November 2025 may result in forfeiture of acceptance of the Application.

Policy for Cancellation by Volga German Tours: Should the tour fail to have a minimum number of 20 applications accepted by 15 November 2025, VGT reserves the right to cancel the tour and all payments received by that date will be refunded to the applicant. VGT will not be responsible for refunds of fees incurred by the applicant for passports or visas.

Policy for Cancellation by Participant: Each tour participant whose Tour Application Form has been accepted but who desires to cancel (for any reason) must provide a written cancellation statement to Brent Mai. The pro-rated refund schedule for cancellation in writing is as follows:

\*received by 1 December 2025: 75% refund (\$4,125 double; \$4,200 single).

\*received by 10 December 2025: 50% refund (\$2,750 double; \$3,000 single).

\*received by 22 December 2025: 25% refund (\$1,375 double; \$1,500 single).

\*received on or after 2 January 2026: zero refund.

#### **Passport and Visa Requirements**

Passport: All travelers are required to have a passport that is valid for at least 6 months after the return date of the trip (which is 11 August 2026). It is the sole responsibility of the traveler to check their passport's expiration date.

**Visa:** A visa is not required for travel by Americans or Canadians to Argentina. Tour participants from other countries should consult requirements for their respective countries. Any visa fee is the responsibility of the tour participant.

### **Mobility and ADA Compliance**

There is neither a minimum nor a maximum permitted age for these tours. Argentina is not subject to the Americans with Disabilities Act (ADA). Much of this tour will take place in rural parts of Argentina where ground and other surfaces may be uneven. There will be considerable walking. Each person must be able to get around under his/her own power. Walkers and motorized chairs and scooters are not permitted. The tour bus will not have a lift. Each participant will be responsible for porting his/her own luggage. Once the tour has started, VGT reserves the right, at its sole discretion, to determine whether or not a tour participant is physically capable of participating in any given activity during the tour. Should a participant be excluded from a particular activity for physical reasons, the participant will not be compensated for such exclusion.

# **COVID Information**

COVID and other health-related regulations and requirements for travel to and from Argentina change frequently. Tour participants are responsible for consulting official government and transportation company websites for the most up-to-date information regarding travel to and from Germany. All costs associated with health testing are the responsibility of the tour participant. Volga German Tours and its officers, agents, and employees are hereby released from all liability for claims related to the testing that may be required by Argentina or any other country. Any costs associated, including but not limited to the need to stay for additional hours or days in Argentina beyond those covered by this tour, are the responsibility of the tour participant. Tour participants are encouraged to obtain, at their own expense, travel insurance that covers unanticipated delays as a consequence of health-related travel restrictions.

# **Health Care Costs**

Each tour participant is encouraged to have health insurance that covers any health-related illness while participating in this tour. It is the sole responsibility

of the tour participant to verify the terms and conditions of any health insurance that is intended to be used during the tour. Regardless of whether a tour participant has such health insurance, all health-related expenses incurred by a tour participant during the tour are the responsibility of the tour participant.

#### Responsibility

Volga German Tours (VGT), Dr. Brent Mai, and their agents act only in the capacity of agents in all matters pertaining to hotel accommodations and meals, sightseeing tours, and transportation. Except for the willful negligence of its direct employees, VGT is not liable for any damage, loss (including but not limited to personal injury, loss of enjoyment, distress, death, and property loss), expense or inconvenience caused by any act or omission of any supplier providing tour services or by any other person or reason whatsoever or by any delays or changes in the itinerary, or the acts and omissions of the tour leader/host or travel agent. VGT assumes no liability or responsibility for any injuries, inconveniences, illness, irregularity, or incidental damages occasioned by circumstances beyond the control of the tour operator, or by any person or reason whatsoever, including but not limited to events such as strikes, revolts, wars, natural disasters, closures of airports, hotels, or included sites, default or omission of any common or private carrier. VGT reserves the right to cancel the tour at any time, to operate the tour with a substitute tour host/leader at any time, to decline or not retain any person as a member of the tour for any cause at any time. VGT reserves the right to make changes in the published itinerary if needed including deleting and adding cities and changing the sequence of the itinerary, or whenever in the sole judgment of VGT as conditions warrant, or if VGT deems it necessary for the comfort, convenience, or safety of the tour. Disputes concerning the terms and conditions of this tour will be handled according to German law.

# **Liability Waiver and Hold Harmless Agreement**

In consideration of being allowed to participate in this tour, Volga German Tours and its officers, agents, and employees are hereby released from all liability for claims by me or arising out of injuries or death to me resulting from my participation in this tour. Volga German Tours and its officers, agents, and employees are hereby indemnified and held harmless from any claims and liability arising out of illness, injuries, death, or damage to others or to property resulting from my use for Volga German Tours. This waiver shall be binding on the members of my family and spouse or partner, if I am alive, and my estate, heirs. assigns, personal representative and all others who might seek to claim through me if I am deceased, and shall be deemed as a RELEASE. WAIVER. DISCHARGE. AND AGREEMENT NOT TO SUE concerning any damages or losses I sustain which stem from the ordinary risks presented by the activities of the Volga German Tours.
